I understand that the route will be over public roads and that vehicular traffic will be encountered. I/we, the undersigned, hold harmless the Port Townsend Bicycle Association, Jefferson County, Washington State Department of Transportation, and the City of Port Townsend and their employees and/or agents and volunteers and any other parties connected with the event for any cost and/or damage sustained by me or the named entrant relating to any accident or injury that might occur while participating in the Rhody Tour and other PTBA events. I understand that there are inherent and other risks involved in the sport of bicycling and that injuries are a common and ordinary occurrence of the sport and I freely assume those risks. I understand that the routes may be challenging and not necessarily chosen for their safety. I further represent that I have the ability and the equipment to handle the route, weather conditions and that I have sufficiently trained and am physically ready for this event. I will wear an ANSI or SNELL approved bicycling helmet while riding in this event.
